I also completed two trips with owners on board cruising the Long Island Sound, and was responsible for maintaining and piloting their 35' Intrepid.

Joined the boat in Huntington NY and completed a successful four day owner's trip in the capacity of captain. Areas Cruised: From Huntington, New York thru Long Island Sound to Block Island then to Newport, RI and back to Huntington, New York

Delivered the boat from Panama to Ft. Lauderdale. Became proficient with Rose Point, Noble Tec Admiralty and Trident editions. Managed 5 crew and took the boat thru an extensive yard period that included the installation of new Quantum Zero Speed Stabilizers and a Lloyd's class survey

Areas Cruised: Panama, Roatan and other Honduran territories, Belize, Mexico, Florida (Ft. Lauderdale down thru the keys with and without guests) and all throughout the Bahamas

April 2012- August 2012 (4 months) position ended due to the sale of the yacht

In those 4 months I did multiple charters and private trips through the Exumas. I operated and maintained a 37' Intrepid as well as an 18' Novarania and 2 Sea Doo's.

I stood watches as the watch leader and was allowed to take Atlantica off and on the dock multiple times.

I acted as assistant engineer. I assisted the solo engineer with various projects, for example replacing a starter for a main engine during charter and keeping up with the engine room daily's while the engineer was away from the boat taking courses.

Stood navigational watches and conducted the ships safety drills

Took the boat thru a major refit at Trinity Shipyards in New Orleans

Assisted the engineer thru an ABS survey

Delivered the boat from New Orleans to Ft. Lauderdale

Removed and inspected thru hull fittings, Removed and inspected valves, Rebuilt various pumps, Painted the main engines and generators, replaced blowers on many of the ships air handlers, serviced and maintained all the ships systems from the dive compressor, two water makers, stabilizers, Head Hunter Tidal Wave sewage system, windlasses and capstans.

As Bosun I would operate and maintain the 35' Intrepid, 18' Novarania and assist the captain and mate with bridge watches, navigation, and pilotage. I was also responsible for keeping the deckhand busy and training him with such tasks as proper operation of both tenders, as well as how to properly maintain the exterior of the yacht.

Areas cruised: Florida, Bahamas, as well as the delivery through the Gulf of Mexico from the Trinity Ship Yard in New Orleans

Duties as mate I was responsible for the exterior as well as maintaining all the ships systems (water maker, treatment system, a/c's as well as both mains and gens). I was also responsible for both tenders and there operation (33' scarab and a 17' aqua scan jet boat). I also assisted our guests in various activities from water sports, hikes, sunset cruises' and beach excursions.

I was also responsible for hiring and managing day workers as well as other contactors.

Areas Cruised: Bahamas, Caribbean, South Florida (Palm Beach thru the Florida Keys)

As deckhand I stood bridge watches to and from Seattle to Costa Rica, operating all three tenders (35' Cabo Sport fish, 27' Shamrock Open fisherman, and 21' Zodiac) Fishing with 4 to 6 guests one week at a time in Costa Rica and Alaska.

Completed a 4 month yard period between seasons which included sometime on a dry dock. Removing and treating rust in the bilges paint and varnish repairs, as well as managing day workers.

Areas cruised: The entire west coast of North America. (Alaska down to Costa Rica)

Duties included exterior maintenance. Periodic instrument and safety checks while underway. Line handling.
